Commerce Initiates Antidumping Duty (AD) Investigation of Large Power Transformers (LPTs) from the Republic of Korea (Korea)

- On August 3, 2011, the Department of Commerce (Commerce) initiated an AD investigation of imports of LPTs from Korea.
- For the purpose of AD investigations, dumping occurs when a foreign company sells a product in the United States at less than normal value.
- The petitioners for this investigation are ABB Inc. (NC, VA, MO), Delta Star Inc. (VA, CA), and Pennsylvania Transformer Technologies, Inc. (PA).
- The scope of this investigation covers large liquid dielectric power transformers having a top power handling capacity greater than or equal to 60,000 kilovolt amperes (60 megavolt amperes), whether assembled or unassembled, complete or incomplete.

Incomplete LPTs are subassemblies consisting of the active part and any other parts attached to, imported with or invoiced with the active parts of LPTs. The "active part" of the transformer consists of one or more of the following when attached to or otherwise assembled with one another: the steel core or shell, the windings, electrical insulation between the windings, the mechanical frame for an LPT.

The product definition encompasses all such LPTs regardless of name designation, including but not limited to step-up transformers, step-down transformers, autotransformers, interconnection transformers, voltage regulator transformers, rectifier transformers, and power rectifier transformers.

- LPTs have a top rating of 60 or more mega-volt amperes (MVA) and are typically used in high voltage electrical power transmission systems to increase, transfer, or decrease the output voltage levels being transmitted to minimize the power lost during transmission.
- The LPTs subject to this investigation are currently classifiable under subheadings 8504.23.0040, 8504.23.0080 and 8504.90.9540 of the Harmonized Tariff Schedule of the United States (HTSUS). Although the HTSUS subheadings are provided for convenience and customs purposes, the written description of the scope of this investigation is dispositive.
- From 2008 to 2010, imports of LPTs from Korea increased 100 percent by quantity (in actual units). In 2010, imports of LPTs from Korea were valued at an estimated \$415 million.

• The U.S. International Trade Commission (ITC) is scheduled to make its preliminary injury determination on or about August 29, 2011.

• If the ITC determines that there is a reasonable indication that imports of LPTs from Korea are materially injuring, or threatening material injury to, the domestic industry, the investigation will continue, and Commerce will be scheduled to make its preliminary determination in December 2011.
